

## Determined Admissions Arrangements and Admissions Criteria for the Academic Year 2020 - 2021

# For: Rise Park Infant School and Rise Park Junior School Admission Policy for the Academic Year 2020 - 2021

Rise Park Academy Trust is comprised of two open academies, Rise Park Infant School and Rise Park Junior School.

Rise Park Infant School is a 4-7 co-educational academy with a planned admission number of 90 pupils for entry into Reception.

Rise Park Junior School is a 7-11 co-educational academy with a planned admission number of 90 pupils into Year 3.

## Applying For a Place - Cohort Applications

You must make an application to the Local Authority for your child to attend Rise Park Infant/Junior Schools.

Rise Park Academy Trust recommends that parents/carers read the 2020/2021 Havering Co-ordinated Admissions Arrangements, available to download from the Infant/Primary section of the Havering website www.havering.gov.uk/admissions before completing any application.

#### Admissions Criteria

If there are more applications than there are places available at Rise Park Infant/Junior Schools, we will use the following criteria, in priority order, to decide which applications to accept (please use full definitions on page 3):

1. Looked After children and children who were looked after, but ceased to be so because they were adopted (or became subject to a residence order or special guardianship order)

- 2. The attendance in September 2020 of a sibling at either Rise Park Infant/Junior Schools
- 3. The distance of the home address from the school, as measured by the Local Authority using a straight line distance from the centre of the schools' quadrant to the home address, those pupils living nearer the school being given the higher priority.

If, because of over-subscription in criteria 1 - 3 above, it is necessary to distinguish between applicants, the distance of the applicant's home address from the Schools, as measured by a straight line from the Schools, will be used with those pupils living nearer the schools being given higher priority.

## Post Offer

Once places have been offered, the parents/carers will be invited to a New Intake meeting and will be asked to bring with them:

- a) A short form birth certificate
- b) Any original document from any U.K. Government Department e.g. a Child benefit letter, or from the National Health Service (N.H.S) e.g. an N.H.S. Registration card, which verifies the address given on the application form.

If, for any reason, the parent/carer is unable to attend, the documents must be brought to the school office prior to the child starting at the School. The School reserves the right to investigate, so far as it considers necessary, any information provided in support of an offer of a school place.
